Dear Brothers and Sisters:

We hope this letter finds everyone in good health and spirit. Thank you for your continued support on the POW/MIA and Veterans issues. We continue to demand for the release of Staff Sgt. Matt Maupin still POW/MIA from Iraqi Freedom and Cmdr. Michael Scott Speicher from Desert Storm. What has happened to our captured troops from past wars? Many of our soldiers have been convicted of war crimes due to their alleged treatment of prisoners. Has our Government tried the enemy for mistreatment and murder of our soldiers and civilians that were captured and executed? Our troops have a tough fight against the War on Terrorism in Afghanistan and Iraq with fatalities high and the number of wounded staggering. We will continue to show our Government that we care and will NOT forget – ever!

We have sent many letters asking the Department of Defense to reinstate POW/MIA from Missing/Captured, their new politically correct version. If they are captured, our fighting men and women deserve to be listed Prisoner of War/Missing In Action. If the Geneva Convention recognizes POW/MIA and all foreign countries recognize POW/MIA; then WHY would the Department of Defense change the status to Missing/Captured? We ALL need to be on the same page so we urge you to send a letter to your State Representatives demanding the reinstatement to the proper title-Prisoner of War/Missing in Action.

Secretary Nicholson's lack of knowledge on the structure of the VA and his inadequacies with budgeting has left the VA consistently under budget. When he needs additional funds for one VA department he takes from another which eventually depletes both departments. He did not budget the cost of the disabled Veterans returning home from the war in Iraq and Afghanistan, which is causing even larger deficit in the VA system.

This year marks the 20th Anniversary of Rolling Thunder and is a great milestone for all of us. We have accomplished a great deal in the past 20 years with the passing of legislation; helping veterans to get the medical treatment they deserve along with their benefits; improved VA healthcare under Sec. Anthony Principi; keeping the POW/MIA issue in public view and supporting our troops serving around the world. When WWI ended the remains of many soldiers were never recovered – on September 26, 2006 the identified remains of a WWI veteran were buried in Arlington National Cemetery. This happened because of your dedication, camaraderie and your demand for accountability over the past 20 years. To those of you who join Rolling Thunder in Washington, D.C. to support our Veterans from past wars, our Veterans serving today and those who were left behind as POW/MIA's, we Thank You!

Keep the faith and we look forward to seeing everyone at **Rolling Thunder XX** on May 27, 2007 in Washington, D.C.
